TLIF0002 – Administer Chain of Responsibility Policies and Procedures

This course has been designed to meet:

1. The nationally recognised unit of competency “TLIF0002 – Administer Chain of Responsibility Policies and Procedures” from the Transport & Logistics Training Package (TLI10/Release 1.0); and
2. The needs of Managers and Supervisors in the Waste & Transport industries.

Chain of Responsibility (COR) legislation was originally drafted by the National Transport Commission in 2003, and approved by the Australian Transport Commission of Ministers in 2004. COR is a concept in transport legislation whereby legal obligations are placed on the parties in the transport supply chain or across the transport industry.

COR was developed to apply in the heavy vehicle industry to address issues of speeding, weight, mass, vehicle loading, driver fatigue and to regulate unlawful behaviour of heavy vehicle drivers who work under the directions of other parties. COR is very similar to the legal concept of ‘duty of care’ that underpins the work, health and safety legislation in NSW.

If you operate in the heavy vehicle industry, consign, pack, load or receive goods as part of your business, then you may be liable at law for breaches of road transport laws even though you have no direct role in driving or operating a heavy vehicle: companies, directors, partners and managers are accountable for the actions of people under their control.

The aim of COR is to make sure everyone in the supply chain shares equal responsibility for ensuring breaches of road transport laws do not occur. This course will provide you and your staff with Implement COR Regulations knowledge and in the process with knowledge and awareness of:

1. Road Safety;
2. How to reduce damage to infrastructure;
3. The deterrence and enforcement objectives;
4. Reasonable steps defence, how to show reasonable steps have been taken, examples of reasonable steps for parties in the supply chain, and relevant case studies;
5. How to improve business efficiency and compliance.

There will be a written assessment at the conclusion of the training session.
