## **CPPWMT3063A Apply Safe Operational Practices When Vehicles Contact Overhead Wires**

This course is designed to:

- Create an awareness of the risks involved in the collection of waste from sites located near electricity and telecommunication system assets;
- Assist managers, supervisors and sales representatives in developing the knowledge and skills required to assess and manage waste collection risks when working near overhead electrical and telecommunication system assets;
- Provide waste collection operators with the knowledge required to avoid electrical hazards; and
- Assess the ability of operators to safely collect waste near all overhead electrical system assets following the WorkCover NSW Code of Practice “Work near overhead power lines” (As agreed between WCRA, and WorkCover on 10 November 2008).

Successful completion of this course will enable participants to:

- Describe hazards associated with contacting live electrical conductors;
- Identify overhead conductor types;
- Describe the conditions under which waste management plant may be operated near live overhead electrical conductors;
- Describe the requirements for making a risk assessment;
- Describe the emergency procedures to be followed if contact is made with an overhead electrical conductor;
- Demonstrate the procedure for safely leaving a waste vehicle in the event of contact with an overhead conductor; and
- Meet the nationally recognised unit of competency “Apply safe operational practices when vehicles contact overhead wires” (CPPWMT3063A) from the Property Services Training Package.

There will be a written assessment at the conclusion of the training session.
