- 185 Members; of which 150 are Ordinary Members
- As per Rule 15 (a) for a quorum at this meeting, 20% of Ordinary Members must be present in person (Nominated Representative) or by proxy
- There were 38 attendees in person or by proxy 25.3%
- 1. Confirm the Minutes of the Half Yearly General Meeting from 9th May 2017, moved by Mr Bayliss, seconded by Mr Gauslaa and carried
- 2. There was no business arising from the 2017 Half Yearly General Meeting
- 3. Review and approve the WCRA Budget for the 2018 / 2019 year
 - Projected budgeted total revenue in 2018/2019 \$725,479
 - Net Surplus \$35,211
 - Capital expenditure \$12,000
 - Moved by Mr Bayliss, seconded by Ms McBurney and the budget was approved
- 4. Review and approve the Membership Fee Structure for the 2018 / 2019 year
 - Currently 150 Ordinary Members; 35 Associate Members
 - ➤ Total invoicing to be sent by 1st June 2018 \$399,625 (plus GST)
 - Moved by Mr Wilson, seconded by Mr Ung and approved.
- 5. General Business discussion took place on the following issues -
 - Recycling challenges, it is our industry and WCRA to continue to act in the best interests of Members & the industry
 - NSW & ACT CDS schemes 6 NSW workshops funded by WCRA, WCRA to fund an ACT workshop
 - National Waste & Recycling Industry Council the Members expressed their continuing support for NWRIC
 - WCRA Executive, four (4) year term to expire in November 2018, noted and Mr Khoury to notify FWC & ROC
