WCRA industry update on Thursday 10 June 2021

Recycling centre opens in Western Sydney

On 30 April 2021, WCRA's Executive Director Tony Khoury attended the official opening of Bingo's \$100 million, state-of-the-art waste processing centre at Eastern Creek. This facility has a 9,000m2 footprint, with the capability to process 7,000 tonnes per day of general, dry waste. In his opening comments, Bingo's CEO, Daniel Tartak stated "Bingo has been encouraged to invest in recycling assets because of government policy that supports the development of a sustainable recycling industry".

Recent Chain of Responsibility court decision from South Australia



Arising from an accident in 2014, an employer was found guilty of 8 counts of failing to comply with their WH&S duty. Magistrate Simon Smart stated, "as the operator of heavy vehicles, the defendant ought reasonably to have known of the risk to heavy vehicles of brake failure on long, downhill routes & the importance of gear selection in a manual

vehicle to control the speed of the vehicle, as well as the importance of ensuring the competence of drivers to undertake such descents". He further said, "there is clear evidence that the employer did not provide such training, instruction or supervision in relation to the driver's competence to drive all routes he may be required to drive in the course of his work. The employer knew or ought to have known that the driver, although the holder of an unrestricted heavy vehicle license under the statutory scheme, had only recently obtained that license and lacked practical experience in the driving of a manual heavy vehicle."

Energy from Waste (EfW)

WCRA's position on EfW was recently communicated to the NSW Government. The submission highlighted that the waste levy should not apply to waste inputs at EfW facilities. WCRA added, in terms of certainty for investors, there needs to be a clear statement on the application or otherwise of future emission limits to existing facilities. With landfill space diminishing, it is vital that stakeholders support the development of a safe, legitimate, compliant & commercially feasible EfW sector.
